

Self-Generation Incentive Program (SGIP) Advance Payment Program (APP) Developer Enrollment Form

The SGIP APP provides SGIP Developers supporting an eligible SGIP project in the Residential Solar and Storage Equity (RSSE) Budget the opportunity to receive 50% of the project's incentive after receiving a Confirmed Reservation Letter, intended to help alleviate upfront cost barriers for low-income Host Customers.

Eligible Project/Host Customers: Residential projects/Host Customers eligible for the RSSE Budget.

Qualified SGIP Developers: SGIP Developers must meet the following requirements:

1. Have and provide an active California State License Bureau (CSLB) license for each APP project.
2. Have previously completed a residential SGIP project and be in good standing under SGIP.
3. Provide both of the following insurance coverages:
 - a. Certificate of Insurance for Commercial General Liability which limit shall not be less than \$1,000,000 each occurrence/\$2,000,000 aggregate for bodily injury, property damage and personal injury.
 - b. Business Auto Insurance which shall be at least as broad as the Insurance Services Office (ISO) Business Auto Coverage form covering Automobile Liability, and which shall not be less than \$1,000,000 each accident for bodily injury and property damage.

SGIP Developers must annually furnish the Program Administrator (PA) with Certificate(s) of Commercial General Liability and Business Auto Insurance.

Additionally, a SGIP Developer may become ineligible to participate in SGIP's APP if the SGIP Developer has less than a B rating with the Better Business Bureau¹ or if the SGIP Developer is on the California Public Utilities Commission Public Watch List of Non-Compliant Solar Providers.²

SGIP Developer Incentive Cap Maximum Limits: SGIP Developers have access to a larger APP incentive cap with an approved Investment Grade Credit (IGC) rating. Developers must provide PAs with the name of accepted credit agency (Fitch Ratings, Moody's, or S&P Golden Ratings) and rating. To be approved for the larger incentive cap, the Developer must have an IGC rating of BBB-/Baa- or above. Developers are required to annually recertify their rating.

SGIP APP Developer and Host Customer Agreement: Qualifying SGIP Developers and Host Customers must agree and sign the SGIP APP Developer and Host Customer Agreement which outlines the APP participation terms and conditions.

SGIP APP Developer Enrollment: Interested SGIP Developers must complete the required information below. Completed form and supporting documentation shall be emailed to SelfGeneration@Socalgas.com. Upon receipt, the PA, in its sole discretion, will notify the SGIP Developer within fifteen (15) business days about their eligibility to participate.
